
#### **Key Findings**

- 1,174 students from 119 schools participated in the Fall Break Learning Academy.
- 89% of parents reported satisfaction with the Fall Break Learning Academy.
- Parents felt that the Learning Academy provided high-quality instruction (83%) and was helpful in supporting their child's learning needs (86%).
- The K-2 grade band had the highest enrollment with  $1^{st}$  graders having the highest grade-level enrollment (n = 201).
- K-8 students received an average of 16.74 additional hours of instruction and high school students received an average of 7.55 hours of ACT prep.

#### **Fall Break Learning Academy**

Fall Break Learning Academy (FBLA) took place from October  $10^{th}$  through the  $14^{th}$ . Students in grades K through 12 participated in this optional 4-day academy. Over eleven-hundred students (n = 1,174) participated in the FBLA. Students in grades K-8 reviewed quarter one standards in the four core-subjects during their 7.5-hour day. High schoolers participated in ACT prep daily from 9:00 AM until noon.

At the conclusion of the Fall Break Learning Academy, a survey was sent out to garner parent feedback. 442 parents responded to the short 15-item survey. The response rate for individual items fluctuated. Items, responses, and additional graphs can be found in <a href="#">Appendix C</a>. Overall, 89% of parents were satisfied with their child's experience at MSCS's Fall Break Learning Academy.






#### **Enrollment, Attendance, and Enrichment**

#### **Enrollment and Attendance**

One thousand one hundred seventy-four students (n = 1,174) from 119 schools participated in the FBLA. at 20 sites throughout the District. (See Appendix A for a list of schools, grades, and enrollment numbers). This represents an increase of 74 students from the previous year. The K-2-grade band had the highest enrollment rate<sup>1</sup> (46%), and first-grade students had the highest enrollment for a single grade (n = 201). Forty-seven percent of students who attended FBLA were classified as Direct Certify (used interchangeably with economically disadvantaged students).



On the survey, parents (n = 418) identified how they became aware of MSCS's Fall Break Learning Academy. Most parents received an email (47%) or text (39%) from their child's teacher, school administrator, or the District about the Fall Break Learning Academy.


Since the program was optional, participation was not mandated. Overall, the average attendance rate was 71% (2.84 days) and 36% of students attended all four days. The K-2

grade band had the highest attendance rate at 74% (see <u>Appendix B</u> for attendance by grade band).




If their child missed any days, parents were asked what the barriers were to the child attending on those days. While most parents who responded did not have barriers, sickness, vacation, and "other" reasons were most frequently cited. The "other" category had responses ranging from "[child] did not want to attend" to scheduled doctors' appointments.


#### **Academic Enrichment**

FBLA delivered 18,973 additional hours of instruction across all the students who participated. This averaged out to 16.74 additional hours of instruction for K–8 students and 7.55 hours for 9–12 students.





Most parents (86%) believed that FBLA was "very helpful" in supporting the learning needs of their students. Additionally, parents believed that FBLA provided high-quality instruction for their child (83%). Seventy-one percent of parents also felt that their student was more prepared for this current school year after attending the FBLA. (Additional graphs are found in Appendix C.)



#### **Other Services**

FBLA also provided needed non-academic resources for students including serving breakfast for all students, lunch for K-8 students, and providing a safe environment during school break. Nearly three thousand meals (n=2,973) were provided to economically disadvantaged students and a total of 6,499 meals were served to all students over the course of the week.

MSCS asked parents what other additional learning supports their child might need this year. Almost 50% of parents indicated interest in the Spring Break Learning Academy. Summer enrichment (40%) and after-school tutoring (+34%) were also common responses.


#### Conclusion
