WHY MSCS PRE-K/HEADSTART?

- **Zero Cost to Parents**
- **Certified/Highly Trained Staff**
- **Develop Kindergarten Readiness**
 - Independence
 - Pre-writing, name writing
 - Letters, numbers, colors and shapes
 - Math concepts
 - Following multi-step directions
- **Communication**
 - Engage in daily conversations with peers and adults
 - Learn to speak in complete sentences
- **Comprehensive Services**
 - Speech, Hearing and Vision screenings
 - Behavior management
- **Family Support Services**
 - Parent education curriculum
 - Crisis support
 - Family events
 - Heard's Homeroom
 - Real Men Read

To be eligible to apply, the child must be 3 or 4 years old before Aug. 15, 2025 and live in Shelby County.

ELIGIBILITY INTERVIEWS BEGIN ON MARCH 4. SPACES FILL UP QUICKLY!

STEPS

- 📍 **STEP 1:** Complete the online application at scsk12.org/PREK or by using the **BLUE** QR code.
- 📍 **STEP 2:** Verify email address and activate Parent Portal using the links in your email from GoEngage. You *must* complete this step to upload documents and receive correspondence.
- 📍 **STEP 3:** Contact the Pre-K Office to schedule the eligibility interview or scan the **RED** QR code.
- 📍 **STEP 4:** Attend an eligibility interview and bring all required documents with you to the assigned interview location.
- 📍 **STEP 5: STOP AND WAIT** on your Eligibility Determination letter.*



NOTE: Only one application per household. List all children on a single application.

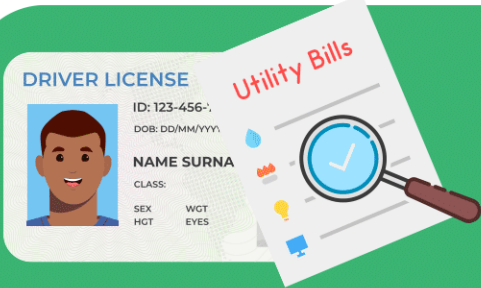

All Documents Required for Enrollment



PROOF OF RESIDENCE TWO (2) TYPES OF PROOF * **

- Mortgage statement/lease, deed in the parent/guardian's name
- Parent/guardian driver's license/state-issued photo ID
- MLGW, telephone bill or municipal water bill
- Any governmental or official court documents with parent/guardian name & address (WIC, Families First, child support, SNAP, SSI, etc.)

*If proof of residence is not in the parent's/guardian's name, a notarized Shared Residence Affidavit must be submitted.

**If lessee /homeowner does not reside in the home, a notarized letter from the lessor/homeowner must be submitted stating they do not live there.

Child's Physical & Immunizations

- Immunizations must be on the TN Certificate of Immunizations and signed or stamped by doctor/clinic.
- Physical must be current within the last 12 months.
- Take-home report or Well Child printout from doctor/clinic (optional)

Child's Dental Exam: Child's dental exam (within the last 12 months) signed by the dentist/clinic that performed the exam.

Child Identification

- Parent's driver's license/state-issued photo ID
- Child must be 4 years old on or before **Aug. 15.**
- If applying for Head Start, child must be 3 years old on or before **Aug. 15.**
- Child's Date of Birth (Birth Certificate, Passport, and Court adoption documents)

Proof of Income

(Must report income for all adults in the household)

- 2024 Income tax return
- 2024 W-2
- Separation Letter (Termination of Employment)
- Federal Assistance eligibility letters, such as Families First/TANF, SSI, Foster Care Payment Letter, or SNAP (does not include P-EBT)
- Military Earning Statement
- Statement from employer on company letterhead

REMINDER: Your application status will be communicated via email. Please ensure you have a working email address.
