Hello Prospective Bidder,

Memphis-Shelby County Schools is pleased to inform vendors that the district continues to utilize an online electronic bidding software for the procurement of goods and services. A new platform was introduced to our vendors in 2023. All suppliers interested in doing business with Memphis-Shelby County Schools are strongly encouraged to register to respond to MSCS' online bid opportunities and receive communications when bid events are issued relating to your goods and services.
