Item #1 – Part II: General Terms and Conditions – 20.2 Option to Renew Contract Period – D:

Regarding request for price adjustments – <u>Original language stated</u>: The request must be submitted in writing at least **sixty (90)** days prior to the renewal term and should be accompanied by supporting documentation.

Corrected to: sixty (60)

Item #2 – Part IV: Scope of Services – 10. Pallets:

<u>Original</u>: Pallets containing cases of six number ten (#10) cans shall have no more than <u>fifty-six (56)</u> cases per pallet to eliminate overhang.

Corrected to: forty-eight (48)

<u>Original</u>: All frozen products shall not be stacked on pallets any higher than <u>sixty inches (56")</u> high. Any loads stacked higher will be required to be broken down by the driver or his/her helper. Extra pallets will be provided, if needed, by this warehouse for stacking <u>sixty-inch (56")</u> pallets. Case weight for each product shall not exceed fifty (50) pounds.
