

1) For the Teacher Kidney Table (Center Base Line 2, School Base Line 3)-- the description lists multiple desktop options, but the cost/pricing for a whiteboard top will be significantly higher than an ordinary laminate top. Can you specify which top is wanted?

White Marker Board Table Top

2) For the Grow Stool (Center Base Line 4, School Base Line 5)-- the image is for a fixed-height stool, while the description says 12"-15", indicating an adjustable stool. However, the adjustable stool doesn't come in a 12"-15" range; the shortest available adjustable stool is 14"-18". Can you confirm which is desired?

Adjustable Active Grow Stool, 14" – 18"H X 13"W X 13"D

3) For the Single Bench with Laminate Top (School Base Line 6)-- all of the other three soft-seating items on the School Base list and all four of the soft-seating items in the Center Base list specify Grade 6 Silica fabric, but this item does not specify. Can you confirm that Grade 6 Silica is required for this item as well?

Grade 6 Silica is required for this item as well

4) Regarding the question in Column L about a 6-week delivery schedule-- given current industry conditions, particularly the steel and lumber shortages, a six-week lead time will be challenging for most manufacturers. How important is the lead time in your evaluation of the bid?

The lead time is critical. Pre-K students start school August 16th. We expect to reach full capacity in classrooms by September 7th.

5) Confirmation that similar items from different manufacturers will be accepted as we manufacture much of our own furniture

We prefer the same manufacture on all shelving and cabinets

6) Confirmation that minor variation in shape is acceptable i.e. desk is 24"x24" adjustable legs (15"-24") to pre-k height of 21" at installation

Table height should adjust to Pre-K height which ranges from 14"-24"



7) Confirmation that bid by a vendor who is not a Mooreco dealer; and, that competitive and economical furniture other than Mooreco Classroom X items will be accepted.

Yes, other vendors are acceptable as long as they meet the specifications

8) Confirmation that bid for Lakeshore specified items be accepted by a vendor other than Lakeshore.

Yes, other vendors are acceptable as long as they meet the specifications

9) Verification that specified item "A Spot for Everyone" rug measurements are actually 9'x12' instead of 9x30 in and that similar rug by different manufacturer will be accepted

"A Spot for Everyone" gives each child their very own space to sit on the rug. Must be at least 20 individual spaces

10) Confirmation that storage units and book display without casters are acceptable as this is manufacturer specific, Jonticraft. Units without casters are the norm and meet safety standards

Yes, storage units and book displays without locking casters is acceptable but recommended

11) Explanation of dates in which SCS wishes to have all the classrooms delivered and installed? Is that flexible.

Pre-K students start school August 16th. We expect to reach full capacity in classrooms no later than September 7th. We have limited furniture to start the school year off and need classrooms delivered and installed as soon as possible.

No, classrooms do not have to be delivered as complete. However, the classrooms are not equipped to store extra product. All product that is shipped should be installed on the day of arrival as much as possible.

20) At what point in the process will a meeting to choose finish and fabric selections be made in an effort to expedite the project?

We have already determined the choices teachers will have of finish and fabric selections. They will available as soon as the PO has been released

21) At schools with 8+ classrooms would a direct to site delivery received by the vendor's installers be acceptable?

Yes, but vendor must be onsite to receive and prepare to install the day of delivery. We do understand larger sites will require multiply days of installation. We will make accommodations to store product at sites with more than 4 classrooms

22) Related to 2.0 of Part II, we are seeing frequent and short notice price increases due to the aforementioned issues with materials and shipping- is it accurate that the pricing offered is only for this project and that the full project will be ordered by August 31st?

Additional product may be purchased after August 31st.
